According to the Order of the Rector № PД - 377 / 21.12.2021 of the Rector of the University "Prof. Dr. Asen Zlatarov" I have been appointed an external member of the scientific jury for the competition. After reviewing the submitted documents, I found what follows:

The only candidate in the announced competition is Chief Assistant Professor Varvara Andonova Pancheva, PhD, Lecturer in the Department of Rehabilitation and Marine Medicine, FPHHC /Faculty of public health and health care/, University "Prof. Dr. Assen Zlatarov". The candidate has submitted, within the legal deadline, documents and evidence in full compliance with the requirements of the Regulations for the development of the academic staff of the University "Prof. Dr. Assen Zlatarov".

I. Biographical data. professional path

Chief Assistant Professor Varvara Andonova Pancheva, PhD graduated in: 1985 from ITHPSSE / Institute for training of health personnel with secondary special education/, Burgas, specialty Nurse - general profile; 1995 Medical College-Burgas, higher medical education, specialty Nurse; 2003 acquires Bachelor's degree in Business Management with a specialization in Health Management; 2009 Master of Health Management, 2011 Master's degree in Health Care Management, the last three of which are at the University "Prof. Dr. Assen Zlatarov". In 2019 has defended the ESD "Doctor" in Social Medicine and Organization of Health and Pharmacy issued by MU-Sofia, Faculty of Public Health.

The professional path of Chief Assistant Professor Varvara Pancheva started as a nurse in DMD, Burgas in 1985, from 1990 to 1994. works in MHAT - Burgas. In 2016 she was the head nurse of the Medical Centre Nadezhda 1 OOD, Chernomorets, and in 2017 she becomes a senior nurse at DCC El Masri OOD, Burgas.

Her teaching career began at the Medical College, Burgas, and later at the Medical College at the University "Prof. Dr. Assen Zlatarov" (1994 to 2009). From 2009 to 2012 is Deputy Director of the Ministry of Culture and Senior Lecturer; in the period 2012-2016 is Deputy Director of the Ministry of Culture and assistant in the Ministry of Culture, PHC, and

Department of Health and Social Care and Department of Physiotherapy, Rehabilitation and Balneology. In the period 2016 until 2019 continues to be an assistant, and from 2020 to this day she is senior assistant.

II. General description of the materials submitted in the competition.

She is an independent author of 6 publications, for 10 of which she is the first author, 2 of them are in English, 12 publications in Bulgarian, 14 in international publications are referenced and indexed in secondary world-famous databases. She has participated in 2 Bulgarian and 17 international conferences.

29 citations are presented.

The scientometric indicators for Chief Assistant Professor Pancheva exceed the required ones according to the regulations of the University "Prof. Dr. Assen Zlatarov" to hold the academic position of "Associate Professor".

III. Evaluation of the candidate's scientific works.

The scientific interests of Chief Assistant Professor Pancheva are in the field of Public Health and Health Care. They have a practical focus in order to improve the health and quality of life of people, organization and management of work in health care, as well as to increase the professional competence of students in the learning process.

They can be grouped into several thematic areas:

- 1. Health promotion and disease prevention prevention of socially significant diseases and prevention of their complications, training and informed health literacy of patients and their environment; (1, 3, 4, 7, 8, 11, 12, 13, 24, 27, 28, 29, 34, 35);
 - 2. Integrated medical and social care for people with chronic diseases; (1, 3, 11, 22, 23, 30);
- 3. Quality of health and nursing care; (1, 2, 3, 4, 5, 6, 9, 10, 12, 14, 16, 17, 21, 22, 23, 24, 25, 26, 30, 31, 32, 33, 34);
- Quality of medical education and professional training of health care professionals; (2, 3, 4, 9, 10, 12, 15, 17, 18, 19, 20, 31);
 - 5. Health management and health care management. (1, 2, 6, 16, 17, 21, 22, 23, 25, 26, 30).

The candidate's research interests and publications are mainly focused on the promotion of health knowledge, training and quality of life of patients with diabetes and the role of the nurse in providing highly effective quality integrated health care. The quality of medical education and professional training of students and health care management are also of scientific interest to Chief Assistant Professor Pancheva, PhD

Her rich professional experience, education, qualifications and training as a professional and lecturer are reflected in scientific publications, monographs and textbooks that contribute to improving the quality of life of patients, organization of health care and assisting students in their professional training.

The main contributions that are derived from the overall research activities of Chief Assistant Professor Pancheva, PhD can be summarized as follows:

- A toolkit for research of medical and social problems in patients with chronic diseases
 has been developed and guidelines for optimizing the model of health care for patients with
 diabetes in pre-hospital care have been proposed;
 - 2. A model for integrated care for patients with diabetes has been created;
- 3. Guidelines were proposed for the preparation of a Diabetes Prevention Program in connection with the currently missing National Program and training program with a methodological focus for patients with type 2 diabetes;

All three have the ability to adapt to other socially significant diseases and chronic diseases:

- Tools for improving the quality and safety of nursing care in hospitals were developed and proposed;
- 5. Methods and means are proposed for: increasing the motivation of the learners; to increase health education and informed health literacy of patients; improving the quality of medical education and the professional knowledge, skills and competencies of healthcare professionals;
- Promotion of the experience from the use of complex multidisciplinary approaches in the care for increasing the health well-being and improving the quality of life of patients with rare, chronic and socially significant diseases;
- 7. Proposals have been made for better communication and interaction in the health team, with patients, with various institutions, with governmental and non-governmental structures in terms of information security, training, improving the quality of health care for prevention and prevention of socially significant diseases;
- 8. The role of patient organizations and the possibilities for using this resource through their integration into the multidisciplinary team for application of innovative approaches in prevention and prevention and integrated care is studied.
