Chief Assistant Professor Hristo Georgiev Burgazliev was born in the city of burgers in 1964 where he graduates the Russian language high school officially Professional high school for foreign languages – Vassil Levski. He graduates a Master's degree in the specialty of the regulated professionals pharmacy in 1989 in the pharmaceutical faculty of Medical University Sofia. In the period 1996 until 1999 he specializes "Organization and economics of the distributary and pharmaceutical practice" In the pharmaceutical faculty of the Medical University of Sofia and in 1999 he is successfully "Specialist". In 1999 he aquires a second master's degree In Business Administration professional qualification Master in Economics. In 2018 he acquires the educational and scientific degree "Doctor" in the scientific specialty "Social medicine and healthcare management" in the National Center of Public Health and Analyses.

His professional career starts as a Master of Pharmacy in a Community Pharmacy, in the period 1996 to 2012 he is a responsible pharmacist and the General Manager of the Community company – "Apteki" LTD Burgas. He has taken various levels of responsible positions in the pharmaceutical wholesale and retail. Mr. Burgazliev Ms. Pharm has significant experience in the filed of the community activities as the member of the leadership of the structures of the Bulgarian Pharmaceutical union. Since 2003 he has

been selected as a visiting lecturer in the Medical faculty of Prof. D-r. Assen Zlatarov" University – Burgas. After entering a competition, he is appointed at the academic position of "Assistant" since March 2018 and "Chief Assistant Professor" since 2019. He teaches in the subjects of "Social pharmacy and pharmaceutical legislation", "Pharmaceutical care", "Social medicine and health promotion", "Ethics and deontology", etc.

Assessment of the qualitative and quantitative professional data on the development of the candidate

Chief Assistant Professor Hristo Georgiev Burgazliev has presented a thorough undersigned proof material, which consists of thorough lists, references, resumes and full-text copies of the scientific works after the appointment on the position of "Chief Assistant Professor", certificates and diplomas, references, declaration for originality and truthfulness of the submitted documents. The presented materials contain all the necessary information for the assessment of the qualitative and quantitative criteria of his complete scientific academic development. The submitted works are in the field of the current competition – "Healthcare and sport", professional field 7.4"Public health", scientific speciality "Social medicine and organization of healthcare and pharmacy".

One habilitation work has been submitted – monography on the B.1. requirement, labelled "Initiation and development in the pharmacy service in the Burgas region", consisting of 520 pages with ISBN 978-619-7126—08-2 and also the monography "Herbs and medical devices in cosmetics" ISBN 978-954-91536—7-5 with a co-author Jalnek Amin. Also submitted are the declarations for equal participation of the other authors in the joint articles. There also is an account of the articles of the author, which have been cited 5 times altogether, along with the articles, in which the citations were made.

The candidate meets the terms for the appointment of the academic position of "Associate Professor" in accordance with member 29 of the Law for the development of the academic staff in the Republic of Bulgaria (LDASRB) and the minimal scientific point requirements for holding the specified position of "Associate Professor" in accordinace with the Act on Development of The Academic Staff in The Republic of Bulgaria Implementing Regulations (ADTASRBIR). In Higher education field—7. Healthcare and sport, professional field—7.4 Public Health. In table 1 I can confirm the scientific metric values, according to which Chief Assistant Professor Hristo Burgazliev meets all the requirements for the appointment in the academic position of "Associate Professor" in accordance with member №73 of the Regulation of the conditions and the order for acquiring of the scientific degrees and appointment at academic positions (RCOASDAAP) in the Prof. D-r. Submitted scientific publications -26 on the $\Gamma8$ requirement. In the group of the $\Gamma9$ requirement there is a one, which is published section in a collective monography.

From the submitted for the competition 38 scientific works, in more than the half of these he is the sole or the initial author (14 articels -29.73%), in 3 articles(18.92%) - second author and in 21 (51.35%) - he is the third or next in row author.

All of the published scientific articles, with which the candidate participates in the competition do not overlap with the publications which the candidate has submitted at the presentation of the dissertation work for the educational degree of "PhD".

He has participated in 2 scientific-research projects, which have been financed by the University.

Main direction of the publication activity

The submitted scientific works of the candidate correspond in subject and content to the four main direction.

- Pharmacovigilance. The candidate verifies in six significant publications his vision that medicinal
 products take a key place in the contemporary therapy of diseases and that in many cases these
 have a lifesaving effects. along with their non-arguable benefits during their use there could be
 adverse drug reactions and the pharmaceutical legislation requires the pharmacist have an
 active role.
- 2. History of Pharmacy. In this field the candidate has long term interests and also significant achievements and great wins for the historical facts in in regional and in national level, there are sent and scientific articles that contain theoretical scientific and practical contributions and they serve to summarize the results of the historiographical research for the functioning of the system of drug procurement and pharmacy service of the population of Bulgaria and more precisely in the region of Burgas in the period after the Ottoman yoke until present day.
- 3. Pharmaco-economics. This is a relatively new scientific direction of the pharmaceutical science and practice worldwide. Its accelerated development during the last decades his own to the

facts of the necessity of objective assessment and effective expenditure of the limited resources in healthcare.

4. National medicine policy, pharmaceutical management and pharmacy regulation. The candidate has published articles which contains theoretical scientific and practical and scientific applicable analyses and results for the functioning of the system of medicine procurement end pharmacy service of the population in the country. It is also available on original research of the various practices for employment of pharmacy students for temporary work in the pharmaceutical sector.

Lecturing activity

As an assistant **Hristo Georgiev Burgazliev** during the last three academical years has an academical workload of a mean of 288 lecturing hours per year. He participates in the teaching of medical social mandatory facultative and elective disciplines on a specific system for the acquirement of the educational qualification rank of a professional Bachelor to students from the specialty assistant pharmacist. He has significant experience and leading lectures and in the management of practical exercises seminars educational practices and also in the pre-diploma pharmaceutical traineeship. The reference for the scientific workload corresponds to the requirements of RCOASDAAP in the Prof. D-r. Assen Zlatarov" University – Burgas.

Conclusion

The review of the materials for the competition for the appointment on the academic position of "Associate Professor" of chief assistant professor **Hristo Georgiev Burgazliev** shows that all the quantitative and qualitative requirements have been met in accordance with the requirements of the law for the development of the academic stuff in the Republic of Bulgaria .The candidates submits a sufficient amount of research articles which consists of original and applicable contributions .
